#### PUBLIC HEARING PROCEDURE

The council shall hold a public hearing on any application for a building permit prior to issuing said permit in all cases where the plans and specifications on the permit application or the proposed location of a structure that will be/is:


- 1. Closer than 15 feet to the front lot line, or,
- 2. Closer than 5 feet to any side lot line, or,
- 3. Closer than 5 feet to any alley adjacent to the property.
- 4. Going to reside in a permanent structure which will be located over underground or which will interfere with overhead gas, water, sewer, electrical, telephone, telegraph, cable television or other public utility transmission lines or systems.
- 5. Located on property which has not been properly subdivided in accordance the state statutes and/or local subdivisions, ordinances and regulations.
- 6. Going to create multiple dwelling units or a hotel on a lot which has previously been used for single family dwelling or non-residential purposes.

Sight Plan & Sketch

- 4. There may be designated setbacks. The property owner is responsible and liable for exact measurements from all lot lines and road right-of-way lines.
- 5. Show shape and dimensions of your lot. <u>State distance from structure(s) to lot line all lot lines.</u>
- 6. Show any public utility (water, sewer, gas, cable, telephone, electric, etc.) in red.
- 7. On moving, show present location in black and proposed location in red.
- 8. On remodeling, show existing walls in black and changes in red.
- 9. Be specific and detailed in your sketch and in your narrative statement, so the application furnishes a complete picture, in words and drawing, of what you propose to do.
- 10. Application and drawing must be complete in its entirety and returned with the building permit fee before it will be processed and approved.
