Russell Conrad reported the following: Unaccounted for water 34.10%, water usage was 832,000 gallons. Tim read meters on 1/22/25. Found leak at 1256 James Ave, repairs needed there and at Swedesburg Parish Hall. Started radio read water project working with Municipal Supply. The city needs to begin cross contamination program surveys soon. Russell announced he is retiring July 31, 2025.

Utility Reports-Sewer - Reviewed monthly DNR report.

City Code Update – SEIRPC will be providing final draft in March.

NPDES

No reply from Disadvantaged Communities application yet. The sewer Permit is submitted but still need to send in required samples (available from discharge effluent) most likely in April.

Heavy Trucks

Discussion regarding heavy trucks on streets causing damage to 4th street culvert. Will invite truck operators to next meeting to discuss ways to mitigate damage and possible other parking arrangements.
