Citizen Forum

Tim Wilson, Dana Wilson, Bruce Hesser, Michelle Hesser, Ben Fear, Mace Barnes spoke to issues with residents of the Men's Facility (apartment house) damaging property and intruding on private property. All mentioned the feeling that it was no longer safe in Olds because of things going on which have escalated. County Law Enforcement responded to the reports. Clerk directed to set up Town Hall meeting with Ryan Dexter (contact) and Gary & Myrna Wenger (building owners) for August 5 at 6:30 p.m. (August 12th-alternate date) at City Hall to go over regulations and security measures and solutions to the problems that have been happening since the facility opened.

Clerk's Report

Will be working on end of fiscal year reports, records are up to date.

Utility Reports-Water

Russell Conrad reported the following: Unaccounted for water 9.82%, water usage was 662,000 gallons. Tim read meters on 6/20. **Utility Reports-Sewer -** Reviewed monthly DNR report.

Backflow Program

John Lins of Iowa Rural Water Association gave information on DNR regulations requiring a water backflow program and that we have records proving installations are done and tested annually. He will provide a sample ordinance that puts responsibility on the customer to protect the water system.

NPDES Compliance

Jim Warner is working on DOT permit for the repair storm drain at Railroad and Main. Randy Seberg outlined the equipment that would be put in place to change us from controlled to continuous discharge. Would have to run for at least six months before getting DNR approval. It will most likely be around \$400,000. Fluence Company willing to up front the construction costs to put in place as a pilot project, which would extend our permit. Construction phase ends when building is in place. Council concurs to continue with sewer improvements with BES Inc. Will schedule a town hall to inform citizens at a future date to discuss project and funding sources. Note, need to complete by January to meet June 30, 2025 sewer permit deadline.

Alcohol License

Rohde moved and Breuer 2nd a motion to approve Class E Retail Alcohol License (LE) from Elliot Oil Company (St. Avenue Stop) effective 8/13/2024. 5 ayes. Motion carried.

Res. 2024-03

Tharp moved and Curry 2nd a motion to approve Res. 2024-03 Resolution Approving An Amendment To The Resolution Authorizing Issuance Of Sewer Revenue Capital Loan Notes Anticipation Project Note, Series 2021, Dated March 26, 2021, And Authorizing Execution And Delivery Of Amendment To Interim Loan And Disbursement Agreement. 5 ayes. Motion carried.
